3. ACCOUNTS NOT PAID within the terms stated above are subject to a service charge on the unpaid balance, for each and every month until same day paid. Any Purchaser Applicant agrees to pay such sums upon demand of Seller.
4. All invoices are payable in Spring, Harris County, Texas at the requested address of Sundance Fuels, Ltd., P.O. Box 2495, Spring, Texas 77383-2495, and Applicant agrees to make payments as required at said address in accordance herewith.
5. In the event a legal action is commenced solely to enforce any of the terms of purchase or obligations created hereby or hereinafter, the legal action will be brought to trial in Harris County and the undersigned agrees to pay whatever sum the court may fix as reasonable attorney's fees and costs.
